Welcome back to the new school year. It's going to be a busy year, especially if the feedback from the consultation to change the school system in Pershore is positive and therefore plans to convert our school to a primary school are approved.

The consultation to support a collective change of age range to align schools in the Pershore Education Planning Area to a single, two-tier (primary and secondary) system of education was published on Monday 2nd September 2024 and will close at noon on Sunday 29th September 2024. In summary, the proposed timeline for change would result in the change of age range at the first schools from September 2025, in line with the removal of the year 5 intake at middle schools in September 2025, and all pupils to transition to Pershore High for year 7 provision from September 2027. If the consultation response is positive it will be our current year 4 cohort who would become the first year 5 cohort at Fladbury.

We would encourage everyone to respond to the consultation, but appreciate you may have a number of questions about it; how it will affect your child(ren); and how we plan to make changes within the school to accommodate two extra years before you feel informed enough to respond. We have therefore organised a consultation information session in the school hall at **7.30pm on Wednesday 11**th **September** and all are invited to attend.


